|  | That afternoon at the SRD Board budget amendments were made. Unfortunately, the amendments to   |

increase funding to the Regional Emergency Preparedness Program did not go forward. The SRD board has listed amongst its strategies to advocate for greater internet connectivity for rural areas, to strengthen relationships with First Nations, and to continue to lobby for quality ferry services for coastal

communities. Other priorities that have made the "A" list are a Regional Community Health Network and the development of an Asset Management Plan.

Councillor Overton Absent Councillor Van Good evening Mayor and Council and members of the public. Solkema I attended the public meeting on Feb. 24<sup>th</sup> wherein George Penfold and company presented the final draft of the Tahsis Economic Development Plan. It was good to hear the presentation by Michael Mghee on behalf of the Mowachat/Muchalat tribal council. It will be interesting to see how our collective plans might come together. I also attended a Nootka Sound Watershed Society AGM, in the big meeting hall at Tsaxana. Mike Wright and Miranda Devisser gave a presentation of the stream assessment progress to date. They plan on being in Gold River again on March 25<sup>th</sup> at Tsaxana to introduce the Risk Assessment Workshop Process. This meeting will begin at 2:00 p.m. for anyone interested and should help us prioritize where future efforts would best be applied. Our local Salmon Enhancement Society were able to voice their opposition to the Esperanza/Hecate sportfishing openings as they were last year based on poor returns to local rivers. This was fully endorsed by the NSWS. The Election of Officers followed directly after the meeting. We now have a new president in Kent O'neil, Dick Dennison is the new vice president. Cheryl Miner is continuing as the acting treasurer and Lyndy Vroom as the recording secretary. Thanks and congratulations to all and many thanks to past president Roger Dunlop and vice president Ken Smith for all their efforts. The Meet and Greet session next weekend will be a good opportunity to gauge future support for a local chapter of Streamkeepers. I'm currently getting some information together regarding this.
