## J. Council Reports

Mayor Schooner (verbal and written report) Good evening Council,

I would like to report that the Village of Tahsis received notification today that their grant application for C2C funding was approved.

In the agenda, under the Mayor's report, I have included the MSC presentation made by Protective Services Manager, Howie Siemens of the SRD (Strathcona Regional District) for council's information. As Chair of the Municipal Services Committee, I am pleased to report that the Committee Directors were open to the suggestion of budget considerations concerning the Emergency Preparedness function, which is something I have been addressing since last year's regional budget on behalf of this community.

Also, since the last council meeting, I met with the regional staff of the (MoTI) Ministry of Transportation and Infrastructure and attended a winter's stakeholder's meeting with Emcon. At both meetings, I reiterated council's advocacy position on concerns regarding Head Bay Road. I addressed both brushing and further seal coating. Council has expressed some concerns regarding the magnesium chloride used for dust control on the road and it has been explained by both MoTI and Emcon that the product has a caustic property, only while wet – once dry that is not a factor. We will have 24 hour attention on the road starting November 12<sup>th</sup> for the upcoming winter conditions. Also, MoTI is reconsidering increasing the speed limit from the Buttle Narrows Bridge to Gold River in consultation with the RCMP and other stakeholders.

I received the actual counts of traffic on Head Bay Road for 2015, so far. The average passes are 102 passes per day. The least amount of passes on the road this year is 16, and the most passes was 233 during one day.

Also, I would like to announce to council, that the motivational speaker, Amber Zirnhelt, whom council agreed to partially fund last year, will be doing a presentation on November 19<sup>th</sup> at the Rec Center. "Amber Zirnhelt is a registered community planner and a motivational speaker. Her passion is in motivating individuals to create the future they desire by finding and pursuing their dreams. Amber is a former professional mountain bike racer that has represented Canada at World Cup competitions in downhill mountain biking, and a member of Canada's National Esteem Team – a team of athletes that do motivational speaking on goal setting, sports, and healthy active living with groups across Canada. Amber is the founder of Ride Like Girl, a BC non-profit, aimed at providing mentorship, bursaries and support for young up and coming female mountain bike athletes." I invite council to be present on the night on the 19<sup>th</sup> at 7 pm.

Also, so you know that I have not been idle, I have attended both a SRD Board meeting and an ICE-T meeting since council last met.
